## NORTHAMPTON TOWNSHIP PARKS AND RECREATION

#### 2025 FREQUENTLY ASKED QUESTIONS – CAMP ADVENTURE

#### **Schedule/Camp Location**

- Camp Adventure operates for 8 weeks from June 23- August 15 (no camp July 4th), Monday-Friday 7:30AM-6:00PM.
- Camp closes at 3:00PM on July 3<sup>rd</sup>.
- Camp is held inside the Recreation Center and on the Recreation Center grounds at 345 Newtown-Richboro Road, Richboro.
- Daily free swim takes place at the Northampton Valley Swim Club, 299 Richboro Rd, Richboro, PA 18954

## When can I drop my camper off? What is the latest I can pick my camper up? What is the procedure?

- Drop off begins at 7:30 AM precisely, children will not be checked-in or permitted in the building until 7:30 AM
- Children can be dropped off at the turnaround and may walk in the front doors, or you may park and
  accompany your child to the check-in area just inside the front doors. A staff member will be posted at the
  attendance area (front desk) to greet each camper.
- On a typical camp day, our daily morning meeting begins **promptly** at 8:45 AM. After morning meeting, groups head to their first activity. To ensure your child doesn't miss out on the excitement, please make sure they arrive by 8:45. **Arrivals after 9:00 AM disrupt the flow of our camp day.** If your child will be arriving late, kindly notify one of our site leaders. If your camper arrives after 9:00AM, they may need to wait until a staff member is available to take them out to their scheduled location, which can cause late campers to completely miss the first activity.
- In order ensure a smooth and safe dismissal process for all campers, and prevent pick-up traffic spilling onto Newtown-Richboro Road, we will no longer be operating a car line at pick-up due to the volume of campers. Instead, we kindly request that you park your vehicle and walk to the building for pickup. Our staff will assist via walkie-talkie to bring your child to you. Please remember that clubs are held on Mondays and Wednesdays from 3:30 to 5:15 PM.
- You will be issued 2 dismissal tags with your child's name on it. When picking up your child, please bring
  the dismissal tag with you to present to the camp staff. YOU WILL NOT BE ABLE TO PICKUP
  WITHOUT THE PICKUP TAG.
- Campers CANNOT BE picked up later than 6 PM. A late fee WILL be assessed if you arrive after 6:00PM

#### What will camp look like for my child on a regular camp day?

- Campers are divided into smaller groups according to the grade they are entering in September. These groups will remain together with 3 4 staff members throughout the summer.
- Each group of campers enjoys indoor and outdoor intramural sports such as kickball, tennis baseball, dodgeball and so many more appropriate games for each age level, special activities, and themed days.
- Campers will have the opportunity to swim every day, weather permitting. In MOST cases, if your child is attending a trip on a given day, they will NOT swim, exceptions will be announced ahead of time.
- Special clubs will be available on Mondays and Wednesdays for a duration of 5 weeks, starting from July 7 and ending on August 6. Club preferences for campers are accommodated by age, beginning with sixth grade. Please note that since this is the 6th grade's final year at Camp Adventure, they will have first choice. While we will make every effort to accommodate your child's preferred club, we cannot guarantee that they will be placed in their top choice.

#### What are your staff requirements? What kind of training do they have?

- Our staff is amazing! We will have 2 site leaders this year: both teachers who have been with NTPR for
  many years. Each group of campers will be led by one experienced group leader. Our group leaders have
  all been counselors at NTPR before and are excellent leaders and role models. They are all super
  enthusiastic and very caring!
- Our counselors are at camp to make a difference in the lives of your child. We are fortunate to have many
  returning staff members each summer. Our staff is cleared through a national criminal and child abuse
  clearance and are required to have CPR/First Aid certification.

#### What happens if someone else is picking up my child?

- If your child is going home with a friend, or someone other than you will be picking your child up on a
  given day, please let the site leader know who will be picking your child up. That person MUST be ready
  to show the proper identification to the camp leader in order for us to release your child. Prior written
  notification is preferred.
- In the event of an emergency or last-minute change, the parent must call or text the Camp Leader or the Camp Director and give verbal consent. The staff member on the phone will take the information given and record it on a "Verbal Consent for Release of Child" form. The person picking up will be asked to show proper identification in order for the child to be released.
- YOUR CHILD WILL NEVER BE RELEASED TO ANYONE WITHOUT PARENTAL CONSENT

#### What should my child bring to camp every day and where do they keep their belongings?

- Please have your child wear their bathing suits under their clothes every day and bring a change of clothes for after their swim time. This saves us TONS of time and prevents crowding in our bathrooms.
- Campers should bring a refillable water bottle, towel and sunscreen with their names CLEARLY MARKED on each item. Swim goggles are allowed at the pool. Please send a spill-proof water bottle with your camper each day. Stanley cups with only a straw are not permitted, as they spill easily. Bottles should have a secure lid since they may be dropped during the day.
- Campers can bring money to purchase a snack at the pool. The menu will be provided as soon as it is available so you have an idea of pricing. Due to unpredictable events, please do not count on the snack bar for your child's snack/lunch.
- Your child should bring their lunch on Tuesdays and Thursdays if they are not going on a trip, and any day
  they do not want to eat the lunch provided. Lunches cannot be refrigerated and should be packed in an
  insulated lunch bag with an ice pack. A drink for lunch is needed every day if your child would like
  something other than water. Lunch will be eaten at the pool, weather permitting.
- Your camper will have a cubby or locker assigned to them to keep their belongings.
- Please leave toys, games, trading cards, and other personal extras at home and refrain from bringing these items to camp- we are not responsible for these items and they cause a distraction to the camp day.
- All campers and staff must wear SNEAKERS in order to participate. Flip flops can be worn at the pool. Campers should wear well-fitting, comfortable clothing to move and play in.

#### Where is my child's money kept?

- Each child has their own "bank account" with Camp Adventure! We have envelopes with each child's name on it that are available to them at the pool.
- Envelopes are kept in a locked cabinet behind the front desk when not in use.
- It is up to you how much money to put in the envelopes. You can give them a daily amount, a weekly amount, or any other way you choose to do it! If your child is not going to be buying any snacks at the

pool, we suggest putting one dollar in if they have a swim band, in case it gets lost. We will mark the envelope should only be used for that purpose.

#### Where does my child swim? How often do they swim?

- Your child will swim daily, weather permitting, at the Northampton Valley Swim Club unless otherwise noted
- All children who are interested or feel ready to swim in the deep water, must pass a deep-water test to earn a swim band. Once earned, **children** will be responsible for their own bands for the duration of the summer. If lost, additional bands are available at the front desk of the swim club for \$1.00.
- Deep water swim tests will be administered daily throughout the summer. If you would prefer to complete the test before camp begins, we will be offering it on Wednesday, June 18th from 12:00 PM to 3:00 PM and again from 5:30 PM to 7:00 PM, as well as on Friday, June 20th from 12:00 PM to 7:00 PM. To take the test, please bring your child to the Swim Club at 299 Richboro Rd, Richboro, and inform the front desk that you are there for the camp swim test.
- During the summer, many campers opt to stay in the shallow end of the pool. While we encourage all
  campers to take their swim test and become stronger swimmers, those who choose to remain in the shallow
  end will have company and supervision.
- It's important to note that all campers will visit the pool daily. If a camper prefers not to swim on a specific day, they will have the option to engage in activities such as basketball, volleyball, gaga, and other games available at the pool area. All counselors go to the pool so there are no staff back at the Recreation Center.
- Campers walk from the Recreation Center to the pool daily.

#### What if my child is taking prescription medication that is required during the camp day?

- Any camper requiring medication during the camp day must have a signed "Medication Log" form on file.
- All medication must be clearly marked with dosage requirements in the original bottle provided by the pharmacist.
- The Camp Directors or Group Leaders dispense and record the medicine daily when it is given to the camper.

#### What if I wish to speak to my child during camp? Are children allowed to carry cell phones?

- Cell phones are not permitted at camp by staff or campers. We take the safety and well-being of our campers, your children, very seriously. Cell phones at camp present a multitude of safety hazards, not to mention they are expensive and can easily be misplaced or lost. Different parents have different rules regarding what is appropriate for their children to view, whether they want their child's picture taken, posted on social media, etc. It is impossible to navigate all of this at camp. Camp is an environment where children and staff laugh, communicate, and enjoy physical exercise. They make connections. There is simply no room for a cell phone. If your child is seen with a cell phone, we will place it at the front desk. If your child needs a cell phone for a reason outside of camp, they can check it in at the front desk in the morning and retrieve it before they leave for the day.
- In the event you need to reach your child or the camp staff, please do not hesitate to contact the Site Leader (green shirt) and they will help you. This phone number is provided in the paper newsletter distributed on the morning of the first day of camp. You may, of course, contact the Camp directly with any concerns or questions at 215-357-5396 or you may call the Parks and Recreation Office at 215-357-6800.

#### How do trips work?

- A trip is scheduled 1 2 times/week. **YOUR CHILD MUST BE REGISTERED FOR ALL TRIPS THEY WISH TO ATTEND NO LATER THAN JUNE 10<sup>st</sup>** to be eligible to attend. This is due to the reservation requirements of the establishments we are traveling to and to ensure we have ordered enough buses. If your child is scheduled to go on the trip, a set time to report to camp is in your trip Itinerary and will have been announced several times leading up to the trip day.
- Camp Carnival Day will be Thursday, July 24<sup>th</sup> at the Civic Center Basin. This camp favorite will bring all of the campers of Adventure, Explore and Expedition together at the Civic Center Basin to a camp carnival. Details to follow.
- There are no refunds for camp trips as trips and buses have been paid for in advance.
- Some children may choose to remain at the camp during trips, (with the exception of Camp Carnival Day) It is ultimately your decision whether you would like to send your child on the trip or have them stay back at camp. We promise, there is still lots of fun happening back at camp!

#### What should my child do on a trip day?

- If your child is scheduled to go on the trip, a set time to report to camp is designated in the trip itinerary and will be announced several times before the day of the trip. Your child must arrive at camp by that time, or they will miss the bus. **The bus will not wait for your child**.
- For his/her safety, your child is given two camp T-shirts to be worn, without exception, on all trips. If your child comes to camp on a day he/she is registered for a trip without their camp T-shirt, we may have extra shirts available, but a \$10.00 fee will be assessed for the cost of the shirt. (Extra shirts are not guaranteed)
- All trip information with dates, times of departure, destination, what to bring and pick-up time are listed on the trip itinerary in this packet.
- **Trip Money:** While your child is welcome to bring spending money on the trip, please note that all necessary items will be provided. The staff will not be responsible for managing or overseeing any camper spending money. The money they put in their "bank" is not brought on the trip- this money is separate for snack money at the pool.

#### How will I know what my child is doing during the camp day?

- A weekly newsletter will be distributed via email and CAMP SOURCE APP reporting on the week that has
  passed and what events are coming up the following week. We also encourage you to have THE BEST
  dinner table conversations EVER!! Your child's day will be jam packed with fun and there will be plenty to
  share!
- The CAMP SOURCE APP-You will receive an email to download the CAMP SOURCE APP. In the email, you will find your username and password. The Camp Source App is a tool where you will find our camp newsfeed, pictures, push notifications, camp trips and events, and any important documents you may need.

#### What is expected of my child at camp?

- Camp participants are expected to always exhibit appropriate behavior while at camp. To provide all campers
  and staff with a positive camp experience that is safe and enjoyable for EACH child, the following guidelines
  have been developed.
- A caring but firm approach is taken regarding discipline. Camp staff will foster appropriate behavior through
  positive reinforcement, firm statements, and redirection of activity. Your children are coming to camp with
  the expectation that they will:
  - o Talk in a pleasant manner. Foul language, putdowns and bullying will not be accepted.
  - o Be safe! Always follow camp and pool rules, bus rules and respect staff.
  - Treat all equipment and supplies with proper care and respect.
  - Show respect for the Parks and Recreation staff, bus drivers and fellow campers.
  - o Aggressive behavior that is threatening to the child, staff or others will not be permitted at camp.
  - Have a positive attitude and have fun!

• Please review these guidelines with your child.

#### What do I do if something happens at camp and my child is unhappy?

• **PLEASE** talk to us! Your child's experience is why we are here! We can help! However, we can only help, give clarification or try to solve conflict if we are aware. Communication is the answer to almost every problem. Do not hesitate to contact the Camp Leader or the Camp Director. Ask a million questions, tell us the problem, whatever is needed to help your child have the best summer ever!

Have one kid in Camp Quest and another in Camp Explore? No problem! Make sure to review this User Guide in full before getting started and use all the App features to enhance your camp experience!

#### Joining Your Camp

New Camp App users will receive an automated email from our system when your information is uploaded into our system. The email will include login credentials and a link to the App in the Apple Store for iPhones or Google Play store for Android devices. The default login is the email provided at registration, along with password 123456. The password should be changed to something more personal after logging in the first time. Once logged in, a **My Camps** screen will appear with all the camps your children are enrolled in. Click it to view the camp information and join the camp. If your camp is not listed there, please contact Parks and Recreation at 215-357-5396 to get enrolled on the App. Each email address will allow two logins on separate devices so both parents or other family members can have access to the App. \*\*All system emails including those with login credentials come from noreply@thesummercampsource.com. If you do not see these emails, please search your system for them. Make sure to add this email to your address book so it does not get caught in spam.

#### **App Menu Items**

Once you have joined, the app will start on the "Newsfeed" screen. The Camp App menu is located at the three small lines in the top right of the App. When you click those lines, a menu will pop out to show: "My Profile", "Calendar" and "My Camps".

#### My Profile: *Updating Your Account Information*

Access profile information in the Camp App Menu. Click on "My Profile" in the menu to see or change account details, child's details, add a picture of your child, and see which camp you are currently viewing in the App. Emails cannot be updated since they are attached to login credentials. If changing emails, please notify your camp to create a new account for you.

#### View "My Camps "

Access "My Camps" information in the Camp App Menu. Click on "My Camps" in the menu to see all the camps you have enrolled in. Once a camp has completed

it will stay in "My Camps" for you to look back on. Camps can also send information after camp ends to alert you of upcoming registrations or events.

#### **Family Members Access**

The Camp App will allow TWO users to be logged in using the same login credentials on different devices. This will allow for a maximum of two parents/guardians to use the app at one time. If different family members wish to view the app, someone has to log out in order to allow someone else to login using the same email and password.

#### **Tracking Notifications**

One of the best features of the Camp App is that it will send a notification anytime something is posted, uploaded or shared on the App so you never miss a thing! If there are multiple kids attending multiple camps, this could still be a lot to keep track of. In the top right of the App you will notice a **bell icon** which is your Notification Tracker. #### **App Features**

You will receive a notification anytime something new is posted in the App so you are always in the loop on camp updates, reminders, and activities. If enrolled in multiple camps at the same time, you may have to toggle between camps to see which camp the notification came from. You can do this in the Notification Tracker or by going to your "My Camps" list in the menu.

#### Here is an overview on what each feature provides

<u>Camp Newsfeed:</u> View any updates and reminders from your camp. Camps may also post fun and engaging content to let you see some of the things they are doing throughout the day!

<u>Pictures:</u> Both these features are listed in the Gallery menu item and separated by a tab on that screen. Camps can upload picture galleries with all the great pictures they took at camp or on a trip. Pictures can be viewed and downloaded directly to your mobile device.

<u>Camp Calendar:</u> Located in the top right of the App, click the Calendar to see all your child's trips, events, and activities. Check with your camp first to make sure that they are using the Calendar in the App. If you do not see your schedules here, your camp may have put them in the Document Center.

<u>Camp Documents:</u> Camps can upload all their schedules, manuals, handouts, supplemental material, and other important information they want to get to you in this section. You can view or download them directly to your mobile device.

#### WAIVER, RELEASE, AND INDEMNIFICATION AGREEMENT

#### PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING, YOU ARE GIVING UP LEGAL RIGHTS

This Waiver, Release, and Indemnification Agreement (<u>Agreement</u>) is entered into by the Adult Participant, and if any minor(s) is/are named below, the Adult Participant on behalf of and as parent or legal guardian for such Child Participant(s) identified below in favor of Broad Street Willow, LLC (<u>Urban Air</u>). Collectively and severally, Adult Participant and Child Participant, their heirs, successors, and assigns are hereinafter referred to as the <u>Participant</u>. In consideration of Urban Air permitting Participant to enter the Premises and participate in the Activities, including the Activities that may occur in, about, or near 1150 Easton Rd, Willow Grove, PA 19090 or any other premises owned or operated by Urban Air wherever located (<u>Premises</u>), Participant agrees as follows:

1. NATURE OF THE ACTIVITIES. Urban Air operates a trampoline and adventure park, which offers Participants (a) the opportunity to participate actively or passively, in trampoline and adventure park related activities, including, but not limited to, jumping, dodgeball, volleyball, tumbling, foam pit jumping, aerobics, skydiving, ninja warrior course, battle beam, laser tag, soft play, ropes course, climbing wall, roller coaster/sky rider, go carts, bowling, bumper cars, cyber sports, mini golf, arcades, exercising, and other miscellaneous trampoline and adventure activities, instruction, training, fitness classes, competition, events, and programs and (b) access to the Premises and cafe (collectively, Activities).

#### 2. Types of Risks.

- 2.1 RISKS AND INJURIES ASSOCIATED WITH ACTIVITIES. Participant acknowledges there are inherent risks in and injuries that may occur from participating in the Activities, including, but not limited to, equipment malfunction; defective design or manufacture of equipment; improper or negligent installation of equipment; negligent maintenance of equipment; cuts; bruises; muscle strain; twisted or sprained ankles, knees, shoulders, or wrists; burns; dirt or other materials in eye; concussions; broken bones; physical or emotional injuries; landing wrong; over-exertion; failure of the attraction surface or attachments; being hit by a ball; collisions with other participants; erratic co-participant behavior; collisions with standards and supports; using improper form or technique; slipping, falling, or tripping; equipment failure; error of judgment by employees; paralysis, disability, or death; personal injury to third persons; or property damage. When skydiving, the most common risk of injury is to the shoulders due to the force of the air on them. When participating in cyber or e-sports, the most common risk of injury is a seizure due to epilepsy. Due to the nature of the Activities, there are more hazards and risks than the foregoing, and there are also unknown and unforeseeable hazards. If you have any questions, please contact a manager before purchasing admission.
- 2.2 EXPOSURE TO BACTERIA, FUNGI, VIRUSES AND UNKNOWN CONTAGIOUS DISEASES. By entering the Premises or when engaging in the Activities, there is a risk of exposure to bacteria, fungi, viruses, unknown contagious diseases and COVID-19, which notwithstanding governmental recommendations and the practices of Urban Air, cannot be eliminated. CONSEQUENTLY, TO THE FULLEST EXTENT PERMITTED BY LAW, PARTICIPANT KNOWINGLY AND FULLY ASSUMES THE RISK OF, RELEASES, AND SHALL INDEMNIFY URBAN AIR FROM ALL CLAIMS (AS DEFINED IN SECTION 5 BELOW) OR BODILY INJURY RESULTING FROM PARTICIPANT'S EXPOSURE TO ANY BACTERIA, FUNGUS, VIRUS, UNKNOWN CONTAGIOUS DISEASES OR COVID-19 AND IN ANY WAY CONNECTED TO PARTICIPANT'S ENTRY INTO THE PREMISES OR ENGAGEMENT IN THE ACTIVITIES. FURTHER, ADULT PARTICIPANT ON BEHALF OF HIM/HERSELF AND THAT OF THE CHILD PARTICIPANT(S) CONSENTS TO HAVING THEIR TEMPERATURE TAKEN BY URBAN AIR AND ACKNOWLEDGES THEY MAY BE DENIED ACCESS TO OR FORCED TO VACATE THE PREMISES IF THEY EVIDENCE SYMPTOMS OF EXPOSURE TO BACTERIA, FUNGUS, VIRUSES, UNKNOWN CONTAGIOUS DISEASES OR COVID-19 AS IDENTIFIED BY THE CENTER FOR DISEASE CONTROL AND PREVENTION.
- 3. <u>ASSUMPTION OF RISKS</u>. Notwithstanding the foregoing risks and the safety measures implemented by Urban Air, Participant acknowledges it is impossible to eliminate all risk of injury and understands the demands of the Activities relative to Participant's physical condition and skill level. PARTICIPANT AFFIRMS THAT PARTICIPATION IN THE ACTIVITIES IS VOLUNTARY AND PARTICIPANT KNOWINGLY, WITH UNDERSTANDING OF THE RISKS AND POTENTIAL INJURIES, ASSUMES ALL RISKS INHERENT WITH THE ACTIVITIES AND ACCESS TO THE PREMISES.
- 4. ALCOHOL. Participant agrees to exercise ordinary and reasonable care and to not consume alcohol to the extent Participant's judgment is impaired. Participant understands the potential risks associated with the consumption of alcohol and acknowledges Participant does not have and is not aware of any medical condition that would result in any injury to Participant due to Participant's consumption of alcohol. Participant assumes the risks associated with alcohol consumption and takes full responsibility for Participant's own actions, safety, and welfare. UNDER NO CIRCUMSTANCES WILL PARTICIPANT BE ALLOWED TO PARTICIPATE IN ANY ACTIVITIES IF PARTICIPANT HAS CONSUMED ALCOHOL.
- 5. Release and Indemnity. To the fullest extent permitted by Law, adult participant on behalf of Himself, Child Participant, and their heirs, executors, and representatives releases, agrees not to sue, and shall indemnify and defend urban air, urban air's franchisor, the legal owner of the premises, the landlord, mortgagees and management company of the premises, and any of their lenders, parents, affiliates, subsidiaries, officers, directors, shareholders, members, managers, partners, agents, employees, contractors, representatives, heirs, assigns, volunteers, independent contractors, equipment suppliers, and insurers of all of them (collectively, protected parties) from and against all liabilities, losses, damages, claims, demands, actions, suits, causes of action, costs, fees, and expenses (including reasonable attorney's fees and court or other costs) (collectively, claims) relating to, resulting from, or arising out of or alleged to have arisen out of (in whole or in part) any property damage or bodily injury (including death) to participant resulting in any way from (a) participant's use of the premises, (b) participant's active or passive participation in the activities, (c) loss or theft of personal property, (d) from the consumption of alcohol at the premises by participant or any other invitee of urban air, or (e) participant's breach of this agreement. This release and indemnity shall apply even if

ANY CLAIM IS CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR STRICT LIABILITY OF THE PROTECTED PARTIES OR PARTICIPANT. THE INDEMNITY SHALL ALSO INCLUDE ADULT PARTICIPANT'S OBLIGATION TO INDEMNIFY THE PROTECTED PARTIES FROM (A) ANY SUM OR SETTLEMENT PAID TO OR ON BEHALF OF THE CHILD PARTICIPANT RESULTING FROM A CLAIM IN ANY WAY INVOLVING THE FOREGOING SUBSECTIONS AND (B) ALL CLAIMS RESULTING FROM OR RELATING TO ANY INSUFFICIENCY OF PARTICIPANT'S LEGAL CAPACITY OR AUTHORITY TO EXECUTE THIS AGREEMENT FOR OR ON BEHALF OF THE CHILD PARTICIPANT.

A. <u>WAIVER OF DAMAGES</u>. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE ADULT PARTICIPANT ON BEHALF OF HIMSELF AND CHILD PARTICIPANT SHALL NOT ASSERT, AND HEREBY WAIVES, ANY CLAIM AGAINST ANY PROTECTED PARTY AND/OR INDEMNITEE, ON ANY THEORY OF LIABILITY, FOR ACTUAL, SPECIAL, INDIRECT, CONSEQUENTIAL, EXEMPLARY OR PUNITIVE DAMAGES ARISING OUT OF, IN CONNECTION WITH, OR AS A RESULT OF, ADULT PARTICIPANT AND/OR CHILD PARTICIPANT'S ENTRY ONTO THE PREMISES AND/OR PARTICIPATION IN ACTIVITIES. NO PROTECTED PARTY AND/OR INDEMNITEE REFERRED IN SECTION 5 ABOVE SHALL BE LIABLE FOR ANY ACTUAL, SPECIAL, INDIRECT, CONSEQUENTIAL, EXEMPLARY OR PUNITIVE DAMAGES ARISING OUT OF, IN CONNECTION WITH, OR AS A RESULT OF, ADULT PARTICIPANT AND/OR CHILD PARTICIPANT'S ENTRY ONTO THE PREMISES AND/OR PARTICIPATION IN ACTIVITIES

#### 6. DISPUTE RESOLUTION.

A. <u>ARBITRATION</u>. Any dispute or claim in any way involving the Child Participant(s), Adult Participant(s), or any one or more of the Protected Parties, arising out of or relating to this Agreement, breach thereof, the Premises, Activities, property damage (real or personal), personal injury (including death), or the scope, arbitrability, or validity of this arbitration agreement (<u>Dispute</u>) shall be brought by the parties in their individual capacity and not as a plaintiff or class member in any purported class or representative capacity, and settled by binding arbitration before a single arbitrator administered by the American Arbitration Association (<u>AAA</u>) per its Commercial Industry Arbitration Rules in effect at the time the demand for arbitration is filed. Judgment on the arbitration award may be entered in any federal or state court having jurisdiction thereof. If the Dispute cannot be heard by the AAA for any reason, the Dispute shall be heard by an arbitrator mutually selected by the parties. If the parties cannot agree upon an arbitrator, then either party may petition an appropriate court to appoint an arbitrator. Arbitration and the enforcement of any award rendered in the arbitration proceedings shall be subject to and governed by the Federal Arbitration Act, 9 U.S.C. § 1 et seq.

B. WAIVER OF JURY TRIAL. TO THE EXTENT PERMITTED BY LAW, ADULT PARTICIPANT ON BEHALF OF HIM/HERSELF AND THE CHILD PARTICIPANT AND URBAN AIR KNOWINGLY, WILLINGLY, AND VOLUNTARILY, WITH FULL AWARENESS OF THE LEGAL CONSEQUENCES, AFTER CONSULTING WITH COUNSEL (OR AFTER HAVING WAIVED THE OPPORTUNITY TO CONSULT WITH COUNSEL) AGREE TO WAIVE THEIR RIGHT TO A JURY TRIAL OF ANY DISPUTE AND TO RESOLVE ANY AND ALL DISPUTES THROUGH ARBITRATION. The right to a trial by jury is a right parties would or might otherwise have had under the Constitutions of the United States of America and the state in which the Premises is located.

- 7. LICENSE. Participant irrevocably grants the Protected Parties the right to take photographs and video of Participant and authorizes the Protected Parties to use, copyright, and publish all or a portion of an image or video of Participant and their name and likeness in all forms and media, including composite or modified representations, for any lawful purpose, including advertising, trade, or any commercial purpose throughout the world and in perpetuity and without compensation. PARTICIPANT WAIVES THE RIGHT TO INSPECT OR APPROVE VERSIONS OF IMAGES OR VIDEOS USED FOR PUBLICATION OR THE WRITTEN COPY THAT MAY BE USED IN CONNECTION WITH THE IMAGES/VIDEOS. PARTICIPANT RELEASES THE PROTECTED PARTIES FROM ANY CLAIMS THAT MAY ARISE REGARDING THE USE OF PARTICIPANT'S STATEMENTS, VIDEOS, OR IMAGES INCLUDING ANY CLAIMS OF DEFAMATION, INVASION OF PRIVACY, OR INFRINGEMENT OF MORAL RIGHTS, RIGHTS OF PUBLICITY, OR COPYRIGHT.
- 8. <u>AUTHORITY</u>. If Adult Participant signs this Agreement on behalf of his/her spouse, child, family member, friend, minor child, or other person, Adult Participant warrants and represents to Urban Air that he/she has the legal authority and such person's actual and implied authority to execute this Agreement on their behalf, including, but not limited to, the arbitration clause, release, indemnity agreement, and license.
- 9. ACKNOWLEDGMENTS. Participant represents to the Protected Parties that this Agreement is a complete and final release and indemnity agreement, that Participant is voluntarily entering into this Agreement, and no representations, promises, or statements made by any of the Protected Parties has influenced Participant in signing this Agreement. Participant agrees that there are no oral agreements, representations, promises, or warranties that are not expressly set forth herein, this Agreement may only be modified in writing, and that Participant is not relying on any statements or representations of the Protected Parties that are not expressly contained herein. Participant expressly agrees that this Agreement is intended to be as broad and inclusive as is permitted by the laws of the state in which the Premises is located and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Venue for any action brought hereunder or due to Participant's use of the Premises or participation in the Activities shall lie in the County in which the Premises is located. The substantive laws of the state in which the Premises is located shall apply.
- 10. REPRESENTATIONS BY PARTICIPANT. Participant represents to the Protected Parties as follows:
  - A. Participant shall obey all rules while participating in the Activities and alert the staff of any rule(s) violation(s), dangerous behavior, or any unusual hazard observed by Participant.
  - B. Participant possesses a sufficient level of skill and physical fitness for safe participation in the Activities.
  - C. Participant shall only attempt Activities that Participant can safely perform.
  - D. Participant is not aware of any health problems that would prevent him/her from participating in the Activities.
  - E. Participant has received either medical clearance from his/her physician prior to participation in the Activities or has determined that such clearance is not necessary for his/her safe participation in the Activities.

- F. Urban Air may, but shall not be obligated or required to, administer to Participant emergency aid, CPR, use an AED (defibrillator), secure emergency medical care or transportation (i.e., EMS), and if said emergency medical care or transportation is secured, Participant shall assume all costs of emergency medical care and transportation.
- G. Participant shall discontinue participation in the Activities if Participant feels any unusual discomfort (e.g., faintness, shortness of breath, physical manifestations of anxiety, chest pains, and/or abnormal heart palpitations).
- H. Participant consents to Urban Air communicating with Participant via telephone or email and to receiving from Urban Air on my wireless device mobile service commercial messages. Participant acknowledges that Participant may be charged by his/her wireless service provider in connection with receipt of such mobile messages.
