2025 FREQUENTLY ASKED QUESTIONS – CAMP QUEST**

**Schedule/Camp Location**

- Regular Quest Camp will be offered for 7 weeks: June 30 – August 14 (no camp July 4),
- Monday - Thursday, 9 AM – 2 PM
- Ultimate Quest Camp will be offered for 7 weeks: June 30 – August 15 (no camp July 4),
- Monday - Friday, 7:30 AM – 6 PM. Camp will close at 3:00PM on 7/3.
- Ultimate and Regular Quest Camp are held inside the Welch Elementary School and on the grounds of Welch Elementary School at 750 New Road and the Northampton Municipal Park grounds. Participants will be dropped off at Welch Elementary.
- Free swim will occur at the Northampton Valley Swim Club, 299 Richboro Rd, Richboro, PA 18954. Regular Quest members can pay an additional fee to be bussed to the pool at 2 pm. Free Swim is included in the fee for Ultimate Quest and there is no additional fee.

**When can I drop my camper off? What is the latest I can pick my camper up? What is the procedure?**

- Drop off begins at 7:30 AM precisely (Mon – Fri) for Ultimate Quest campers. Children will not be checked-in or be permitted in the building until 7:30 AM. Regular Quest Campers can be dropped off at 9 AM, Mon - Thurs. *For your child's safety, please do not drop off before your designated time, as we staff according to the number of children we have at a given time.*
- On a typical, **non-trip day**, pick- up will occur at 2:00 PM for regular Quest participants. Please form a car line facing New Road at the gym entrance of the school. **A staff member will be outside with a walkie-talkie to call your child out. You are required to sign out your child.**
- Ultimate Quest and Regular Quest swimmers will be picked up from the pool (Northampton Valley Swim Club, 299 Newtown-Richboro Road, Richboro) **Parents must park and walk into the pool area to sign their camper out for the day.**
- On long trip days, pick up will take place at Welch Elementary School at the designated time. Each child will still have to be checked out before we can dismiss them safely. We appreciate your cooperation!
- Please be patient, the first week is always a little slower as staff, parents and campers find their footing and adjust where necessary, we will get there!

**What will camp look like for my child on a regular camp day?**

- Ultimate Quest campers will have organized free play consisting of cards, ping pong, Nok Hockey and gym games in the morning when they arrive.
- At around 9:15 AM, Campers will be placed in attendance groups and assigned to a counselor. After attendance each day, a rotation of a variety of activities will be presented and campers will be able to choose indoor and outdoor activities with their friends according to their interests. Various sports, games and activities are selected based on camper input and attention paid to the comfort level of each child.
- Campers have snack and lunch (must be provided unless specified).
- Dismissal is at 2 PM for Regular Quest Campers. Swim after Quest and Ultimate Quest campers will be transported to the pool for an afternoon of swim and fun! There is a pool snack bar, the menu and price list will be provided when it is available.
- If it is raining on a pool day, campers will remain at Welch Elementary, and parents will be notified via email and text.

### What are your staff requirements? What kind of training do they have?

- Our staff is amazing! Quest is led by two experienced leaders who have significant experience at camp . Our leaders are majoring in education and have many years of camp experience. The remaining staff is rounded out by other college graduates and college students, some majoring in education. They are all super enthusiastic and very caring!
- All staff have completed three required background checks, mandated reporter training, and are First/Aid CPR/AED/Epipen trained and certified by the American Red Cross. All staff completes training on policies, procedures, and how to be FUN and keep campers SAFE, and create meaning, acceptance, and connection within the camp setting throughout the summer.

### What happens if someone else is picking up my child?

- If your child is going home with a friend, or someone other than you will be picking your child up on a given day, please send a note in with your child indicating who will be picking him/her up. That person MUST be ready to show the proper identification to the camp leader in order for us to release your child. Prior written notification is preferred.
- In the event of an emergency or last-minute change, the parent must call the Camp Leader or the Camp Director and give verbal consent. The staff member on the phone will take the information given and record it on a “Verbal Consent for Release of Child” form. The person picking up will be asked to show proper identification in order for the child to be released.
- **YOUR CHILD WILL NEVER BE RELEASED TO ANYONE WITHOUT PARENTAL CONSENT**

### What should my child bring to camp everyday and where do they keep their belongings?

- If your child will be swimming, a bathing suit should be worn under clothes or brought in a separate bag to camp. Campers should also bring sunscreen and a towel. You may also want to bring goggles for the pool and/or money for the snack bar. **NAMES MUST BE CLEARLY MARKED ON ALL PERSONAL BELONGINGS.**
- All campers should bring a refillable water bottle with their first and last name **CLEARLY MARKED.**
- Your child should bring their lunch everyday unless otherwise specified (check trip itinerary to see if lunch is provided). Lunches cannot be refrigerated and should be packed in an insulated lunch bag with an ice pack. A drink for lunch is needed every day if your child would like something different than water.
- Your child will keep their belongings in a classroom during the camp day. Campers must take all items home with them at the end of every camp day.
- **All campers and staff must wear SNEAKERS in order to participate. Flip flops can be worn at the pool. Campers should wear well-fitting, comfortable clothing to move and play in.**

### What if my child is taking prescription medication that is required during the camp day?

- Any camper requiring medication during the camp day must have a signed “Medication Log” form on file.
- All medication must be clearly marked with dosage requirements in the original bottle provided by the pharmacist.
- The Camp Leader or Group Leaders dispense and record the medicine daily when it is given to the camper.

### What if I wish to speak to my child during camp? Are children allowed to carry cell phones?

- Cell phones are permitted at Quest, but must be off and inside bags at ALL TIMES WITHOUT EXCEPTION. Staff are required to check phones in their break room before engaging with campers at the beginning of the day. We take the safety and well-being of our campers, your children, very seriously. Cell phones at camp present a multitude of safety hazards, not to mention they are expensive and can easily be misplaced or lost. Different parents have different rules regarding what is appropriate for their children to view, whether they want their child's picture taken, posted on social media, etc. It is impossible to navigate all of this at camp. Camp is an environment where children and staff laugh, communicate, and enjoy physical exercise. There is simply no room for a cell phone. If your child is seen with a cell phone, we will instruct them to put it back in their bags. In the event the child continues to use their phone, staff will hold it until pick up. Smart watches are not permitted.
- In the event you need to reach your child or the camp staff, please do not hesitate to contact the Site Leader (green shirt) and they will help you. This phone number is provided in the paper newsletter distributed on the morning of the first day of camp. You may, of course, contact the Camp directly with any concerns or questions at 215-357-5396 or you may call the Parks and Recreation Office at 215-357-6800 and someone from the department will do their best to help you.

### How will I know what my child is doing during the camp day?

- A weekly newsletter will be distributed via email and The Camp Source App reporting on the week that has passed and what events are coming up the following week. We also encourage you to have THE BEST dinner table conversations EVER!! Your child's day will be jam packed with fun and there will be plenty to share!
- The **CAMP SOURCE APP**-You will receive an email to download the CAMP SOURCE APP. In the email, you will find your username and password. The Camp Source App is a tool where you will find our camp newsfeed, pictures, push notifications, camp trips and events, and any important documents you may need.

### How often are trips scheduled?

- Approximately 2 trips will be taken each week. **Even though payment of trips is included in your fee, each child must be registered online at [www.northamptonrec.com](http://www.northamptonrec.com) by June 10, 2025.** For safety reasons, it is imperative that the camp is aware of who we are taking on each trip. It is also vitally important that we know we have enough tickets purchased and enough buses to transport the children. The Camp Leader needs accurate trip attendance sheets BEFORE camp begins.
- Due to the cost of transportation and the coach bus- there is a fee for the Camel Beach trip of \$35.

### What should my child do on a trip day?

- If your child is scheduled to go on the trip, a set time to report to camp is designated in the trip itinerary and will be announced several times before the day of the trip. Your child must arrive at camp by that time, or they will miss the bus. **The bus will not wait for your child.**
- For his/her safety, your child is given two camp T-shirts to be worn, without exception, on all trips. If your child comes to camp on a day he/she is registered for a trip without their camp T-shirt, we may have extra shirts available, but a \$10.00 fee will be assessed for the cost of the shirt. (Extra shirts are not guaranteed)
- All trip information with dates, times of departure, destination, what to bring and pick-up time are listed on the trip itinerary in this packet.

**What is expected if my child cannot attend a trip?**

- Most campers attend all trips because they are included in the camp fee. If they do not attend, it is normally due to a family vacation or an extra-curricular activity that prevents them from attending. Unfortunately, we do not have enough staff to stay back with a very small number of children who do not wish to attend a trip.  
*There is no camp for children who are not registered for a trip.*

**What is expected of my child at camp?**

- Camp participants are expected to exhibit appropriate behavior at all times while at camp. In order to provide all campers and staff with a positive camp experience that is safe and enjoyable for EACH child, the following guidelines have been developed.
- A caring approach will be taken regarding discipline. Camp staff will foster appropriate behavior through positive reinforcement, firm statements and redirection of activity. Your children are coming to camp with the expectation that they will:
  - Talk in a pleasant manner. Foul language, putdowns and bullying will not be accepted.
  - Be safe! Always follow camp and pool rules, bus rules and respect staff.
  - Treat all equipment and supplies with proper care and respect.
  - Show respect for the Parks and Recreation staff, bus drivers and fellow campers.
  - Aggressive behavior that is threatening to the child, staff or others will not be permitted at camp.
  - Have a positive attitude and have fun!
- Please review these guidelines with your child.

**What do I do if something happens at camp and my child is unhappy?**

- **PLEASE** talk to us! Your child's experience is why we are here! We can help! However, we can only help, give clarification or try to solve conflict if we are aware. Communication is the answer to almost every problem. Do not hesitate to contact the Camp Leader or the Camp Director. Ask a million questions, tell us the problem, whatever is needed to help your child have the best summer ever!

## **Joining Your Camp**

New Camp App users will receive an automated email from our system when your information is uploaded into our system. The email will include login credentials and a link to the App in the Apple Store for iPhones or Google Play store for Android devices. The default login is the email provided at registration, along with password 123456. The password should be changed to something more personal after logging in the first time. Once logged in, a **My Camps** screen will appear with all the camps your children are enrolled in. Click it to view the camp information and join the camp. If your camp is not listed there, please contact Parks and Recreation at 215-357-5396 to get enrolled on the App. Each email address will allow two logins on separate devices so both parents or other family members can have access to the App. \*\*All system emails including those with login credentials come from [noreply@thesummercampsources.com](mailto:noreply@thesummercampsources.com). If you do not see these emails, please search your system for them. Make sure to add this email to your address book so it does not get caught in spam.

## **App Menu Items**

Once you have joined, the app will start on the "Newsfeed" screen. The Camp App menu is located at the three small lines in the top right of the App. When you click those lines, a menu will pop out to show: "My Profile", "Calendar" and "My Camps".

### **My Profile: *Updating Your Account Information***

Access profile information in the Camp App Menu. Click on "My Profile" in the menu to see or change account details, child's details, add a picture of your child, and see which camp you are currently viewing in the App. Emails cannot be updated since they are attached to login credentials. If changing emails, please notify your camp to create a new account for you.

### **View "My Camps "**

Access "My Camps" information in the Camp App Menu. Click on "My Camps" in the menu to see all the camps you have enrolled in. Once a camp has completed

it will stay in "My Camps" for you to look back on. Camps can also send information after camp ends to alert you of upcoming registrations or events.

### **Family Members Access**

The Camp App will allow TWO users to be logged in using the same login credentials on different devices. This will allow for a maximum of two parents/guardians to use the app at one time. If different family members wish to view the app, someone has to log out in order to allow someone else to login using the same email and password.

### **Tracking Notifications**

One of the best features of the Camp App is that it will send a notification anytime something is posted, uploaded or shared on the App so you never miss a thing! If there are multiple kids attending multiple camps, this could still be a lot to keep track of. In the top right of the App you will notice a **bell icon** which is your Notification Tracker. Pictures: Both these features are listed in the Gallery menu item and separated by a tab on that screen. Camps can upload picture galleries with all the great pictures they took at camp or on a trip. Pictures can be viewed and downloaded directly to your mobile device.

## WAIVER, RELEASE, AND INDEMNIFICATION AGREEMENT

### **PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING, YOU ARE GIVING UP LEGAL RIGHTS**

This Waiver, Release, and Indemnification Agreement (Agreement) is entered into by the Adult Participant, and if any minor(s) is/are named below, the Adult Participant on behalf of and as parent or legal guardian for such Child Participant(s) identified below in favor of Broad Street Willow, LLC (Urban Air). Collectively and severally, Adult Participant and Child Participant, their heirs, successors, and assigns are hereinafter referred to as the Participant. In consideration of Urban Air permitting Participant to enter the Premises and participate in the Activities, including the Activities that may occur in, about, or near 1150 Easton Rd, Willow Grove, PA 19090 or any other premises owned or operated by Urban Air wherever located (Premises), Participant agrees as follows:

1. NATURE OF THE ACTIVITIES. Urban Air operates a trampoline and adventure park, which offers Participants (a) the opportunity to participate actively or passively, in trampoline and adventure park related activities, including, but not limited to, jumping, dodgeball, volleyball, tumbling, foam pit jumping, aerobics, skydiving, ninja warrior course, battle beam, laser tag, soft play, ropes course, climbing wall, roller coaster/sky rider, go carts, bowling, bumper cars, cyber sports, mini golf, arcades, exercising, and other miscellaneous trampoline and adventure activities, instruction, training, fitness classes, competition, events, and programs and (b) access to the Premises and cafe (collectively, Activities).

#### 2. TYPES OF RISKS.

2.1 RISKS AND INJURIES ASSOCIATED WITH ACTIVITIES. Participant acknowledges there are inherent risks in and injuries that may occur from participating in the Activities, including, but not limited to, equipment malfunction; defective design or manufacture of equipment; improper or negligent installation of equipment; negligent maintenance of equipment; cuts; bruises; muscle strain; twisted or sprained ankles, knees, shoulders, or wrists; burns; dirt or other materials in eye; concussions; broken bones; physical or emotional injuries; landing wrong; over-exertion; failure of the attraction surface or attachments; being hit by a ball; collisions with other participants; erratic co-participant behavior; collisions with standards and supports; using improper form or technique; slipping, falling, or tripping; equipment failure; error of judgment by employees; paralysis, disability, or death; personal injury to third persons; or property damage. When skydiving, the most common risk of injury is to the shoulders due to the force of the air on them. Due to the nature of the Activities, there are more hazards and risks than the foregoing, and there are also unknown and unforeseeable hazards. 2.2 EXPOSURE TO BACTERIA, FUNGI, VIRUSES AND UNKNOWN CONTAGIOUS DISEASES. By entering the Premises or when engaging in the Activities, there is a risk of exposure to bacteria, fungi, viruses, unknown contagious diseases and COVID-19, which notwithstanding governmental recommendations and the practices of Urban Air, cannot be eliminated. **CONSEQUENTLY, TO THE FULLEST EXTENT PERMITTED BY LAW, PARTICIPANT KNOWINGLY AND FULLY ASSUMES THE RISK OF, RELEASES, AND SHALL INDEMNIFY URBAN AIR FROM ALL CLAIMS (AS DEFINED IN SECTION 5 BELOW) OR BODILY INJURY RESULTING FROM PARTICIPANT'S EXPOSURE TO ANY BACTERIA, FUNGUS, VIRUS, UNKNOWN CONTAGIOUS DISEASES OR COVID-19 AND IN ANY WAY CONNECTED TO PARTICIPANT'S ENTRY INTO THE PREMISES OR ENGAGEMENT IN THE ACTIVITIES. FURTHER, ADULT PARTICIPANT ON BEHALF OF HIM/HERSELF AND THAT OF THE CHILD PARTICIPANT(S) CONSENTS TO HAVING THEIR TEMPERATURE TAKEN BY URBAN AIR AND ACKNOWLEDGES THEY MAY BE DENIED ACCESS TO OR FORCED TO VACATE THE PREMISES IF THEY EVIDENCE SYMPTOMS OF EXPOSURE TO BACTERIA, FUNGUS, VIRUSES, UNKNOWN CONTAGIOUS DISEASES OR COVID-19 AS IDENTIFIED BY THE CENTER FOR DISEASE CONTROL AND PREVENTION.**

3. ASSUMPTION OF RISKS. Notwithstanding the foregoing risks and the safety measures implemented by Urban Air, Participant acknowledges it is impossible to eliminate all risk of injury and understands the demands of the Activities relative to Participant's physical condition and skill level. **PARTICIPANT AFFIRMS THAT PARTICIPATION IN THE ACTIVITIES IS VOLUNTARY AND PARTICIPANT KNOWINGLY, WITH UNDERSTANDING OF THE RISKS AND POTENTIAL INJURIES, ASSUMES ALL RISKS INHERENT WITH THE ACTIVITIES AND ACCESS TO THE PREMISES.**

4. ALCOHOL. Participant agrees to exercise ordinary and reasonable care and to not consume alcohol to the extent Participant's judgment is impaired. 5. RELEASE AND INDEMNITY. **TO THE FULLEST EXTENT PERMITTED BY LAW, ADULT PARTICIPANT ON BEHALF OF HIMSELF, CHILD PARTICIPANT, AND THEIR HEIRS, EXECUTORS, AND REPRESENTATIVES RELEASES, AGREES NOT TO SUE, AND SHALL INDEMNIFY AND DEFEND URBAN AIR, URBAN AIR'S FRANCHISOR, THE LEGAL OWNER OF THE PREMISES, THE LANDLORD, MORTGAGEES AND MANAGEMENT COMPANY OF THE PREMISES, AND ANY OF THEIR LENDERS, PARENTS, AFFILIATES, SUBSIDIARIES, OFFICERS, DIRECTORS, SHAREHOLDERS, MEMBERS, MANAGERS, PARTNERS, AGENTS, EMPLOYEES, CONTRACTORS, REPRESENTATIVES, HEIRS, ASSIGNS, VOLUNTEERS, INDEPENDENT CONTRACTORS, EQUIPMENT SUPPLIERS, AND INSURERS OF ALL OF THEM (COLLECTIVELY, PROTECTED PARTIES) FROM AND AGAINST ALL LIABILITIES, LOSSES, DAMAGES, CLAIMS, DEMANDS, ACTIONS, SUITS, CAUSES OF ACTION, COSTS, FEES, AND EXPENSES (INCLUDING REASONABLE ATTORNEY'S FEES AND COURT OR OTHER COSTS) (COLLECTIVELY, CLAIMS) RELATING TO, RESULTING FROM, OR ARISING OUT OF OR ALLEGED TO HAVE ARISEN OUT OF (IN WHOLE OR IN PART) ANY PROPERTY DAMAGE OR BODILY INJURY (INCLUDING DEATH) TO PARTICIPANT RESULTING IN ANY WAY FROM (A) PARTICIPANT'S USE OF THE PREMISES, (B) PARTICIPANT'S ACTIVE OR PASSIVE PARTICIPATION IN THE ACTIVITIES, (C) LOSS OR THEFT OF PERSONAL PROPERTY, (D) FROM THE CONSUMPTION OF ALCOHOL AT THE PREMISES BY PARTICIPANT OR ANY OTHER INVITEE OF URBAN AIR, OR (E) PARTICIPANT'S BREACH OF THIS AGREEMENT. THIS RELEASE AND INDEMNITY SHALL APPLY EVEN IF**

**ANY CLAIM IS CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR STRICT LIABILITY OF THE PROTECTED PARTIES OR PARTICIPANT. THE INDEMNITY SHALL ALSO INCLUDE ADULT PARTICIPANT'S OBLIGATION TO INDEMNIFY THE PROTECTED PARTIES FROM (A) ANY SUM OR SETTLEMENT PAID TO OR ON BEHALF OF THE CHILD PARTICIPANT RESULTING FROM A CLAIM IN ANY WAY INVOLVING THE FOREGOING SUBSECTIONS AND (B) ALL CLAIMS RESULTING FROM OR RELATING TO ANY INSUFFICIENCY OF PARTICIPANT'S LEGAL CAPACITY OR AUTHORITY TO EXECUTE THIS AGREEMENT FOR OR ON BEHALF OF THE CHILD PARTICIPANT.**

**A. WAIVER OF DAMAGES.** TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE ADULT PARTICIPANT ON BEHALF OF HIMSELF AND CHILD PARTICIPANT SHALL NOT ASSERT, AND HEREBY WAIVES, ANY CLAIM AGAINST ANY PROTECTED PARTY AND/OR INDEMNITEE, ON ANY THEORY OF LIABILITY, FOR ACTUAL, SPECIAL, INDIRECT, CONSEQUENTIAL, EXEMPLARY OR PUNITIVE DAMAGES ARISING OUT OF, IN CONNECTION WITH, OR AS A RESULT OF, ADULT PARTICIPANT AND/OR CHILD PARTICIPANT'S ENTRY ONTO THE PREMISES AND/OR PARTICIPATION IN ACTIVITIES. NO PROTECTED PARTY AND/OR INDEMNITEE REFERRED IN SECTION 5 ABOVE SHALL BE LIABLE FOR ANY ACTUAL, SPECIAL, INDIRECT, CONSEQUENTIAL, EXEMPLARY OR PUNITIVE DAMAGES ARISING OUT OF, IN CONNECTION WITH, OR AS A RESULT OF, ADULT PARTICIPANT AND/OR CHILD PARTICIPANT'S ENTRY ONTO THE PREMISES AND/OR PARTICIPATION IN ACTIVITIES

6. DISPUTE RESOLUTION.

**A. ARBITRATION.** Any dispute or claim in any way involving the Child Participant(s), Adult Participant(s), or any one or more of the Protected Parties, arising out of or relating to this Agreement, breach thereof, the Premises, Activities, property damage (real or personal), personal injury (including death), or the scope, arbitrability, or validity of this arbitration agreement (Dispute) shall be brought by the parties in their individual capacity and not as a plaintiff or class member in any purported class or representative capacity, and settled by binding arbitration before a single arbitrator administered by the American Arbitration Association (AAA) per its Commercial Industry Arbitration Rules in effect at the time the demand for arbitration is filed. Judgment on the arbitration award may be entered in any federal or state court having jurisdiction thereof. If the Dispute cannot be heard by the AAA for any reason, the Dispute shall be heard by an arbitrator mutually selected by the parties. If the parties cannot agree upon an arbitrator, then either party may petition an appropriate court to appoint an arbitrator. Arbitration and the enforcement of any award rendered in the arbitration proceedings shall be subject to and governed by the Federal Arbitration Act, 9 U.S.C. § 1 et seq.

**B. WAIVER OF JURY TRIAL.** **TO THE EXTENT PERMITTED BY LAW, ADULT PARTICIPANT ON BEHALF OF HIM/HERSELF AND THE CHILD PARTICIPANT AND URBAN AIR KNOWINGLY, WILLINGLY, AND VOLUNTARILY, WITH FULL AWARENESS OF THE LEGAL CONSEQUENCES, AFTER CONSULTING WITH COUNSEL (OR AFTER HAVING WAIVED THE OPPORTUNITY TO CONSULT WITH COUNSEL) AGREE TO WAIVE THEIR RIGHT TO A JURY TRIAL OF ANY DISPUTE AND TO RESOLVE ANY AND ALL DISPUTES THROUGH ARBITRATION.** The right to a trial by jury is a right parties would or might otherwise have had under the Constitutions of the United States of America and the state in which the Premises is located.

7. LICENSE. Participant irrevocably grants the Protected Parties the right to take photographs and video of Participant and authorizes the Protected Parties to use, copyright, and publish all or a portion of an image or video of Participant and their name and likeness in all forms and media, including composite or modified representations, for any lawful purpose, including advertising, trade, or any commercial purpose throughout the world and in perpetuity and without compensation. **PARTICIPANT WAIVES THE RIGHT TO INSPECT OR APPROVE VERSIONS OF IMAGES OR VIDEOS USED FOR PUBLICATION OR THE WRITTEN COPY THAT MAY BE USED IN CONNECTION WITH THE IMAGES/VIDEOS. PARTICIPANT RELEASES THE PROTECTED PARTIES FROM ANY CLAIMS THAT MAY ARISE REGARDING THE USE OF PARTICIPANT'S STATEMENTS, VIDEOS, OR IMAGES INCLUDING ANY CLAIMS OF DEFAMATION, INVASION OF PRIVACY, OR INFRINGEMENT OF MORAL RIGHTS, RIGHTS OF PUBLICITY, OR COPYRIGHT.**

8. AUTHORITY. If Adult Participant signs this Agreement on behalf of his/her spouse, child, family member, friend, minor child, or other person, Adult Participant warrants and represents to Urban Air that he/she has the legal authority and such person's actual and implied authority to execute this Agreement on their behalf, including, but not limited to, the arbitration clause, release, indemnity agreement, and license.

9. ACKNOWLEDGMENTS. Participant represents to the Protected Parties that this Agreement is a complete and final release and indemnity agreement, that Participant is voluntarily entering into this Agreement, and no representations, promises, or statements made by any of the Protected Parties has influenced Participant in signing this Agreement. Participant agrees that there are no oral agreements, representations, promises, or warranties that are not expressly set forth herein, this Agreement may only be modified in writing, and that Participant is not relying on any statements or representations of the Protected Parties that are not expressly contained herein. Participant expressly agrees that this Agreement is intended to be as broad and inclusive as is permitted by the laws of the state in which the Premises is located and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. Venue for any action brought hereunder or due to Participant's use of the Premises or participation in the Activities shall lie in the County in which the Premises is located. The substantive laws of the state in which the Premises is located shall apply.

10. REPRESENTATIONS BY PARTICIPANT. Participant represents to the Protected Parties as follows:

- A. Participant shall obey all rules while participating in the Activities and alert the staff of any rule(s) violation(s), dangerous behavior, or any unusual hazard observed by Participant.
- B. Participant possesses a sufficient level of skill and physical fitness for safe participation in the Activities.
- C. Participant shall only attempt Activities that Participant can safely perform.
- D. Participant is not aware of any health problems that would prevent him/her from participating in the Activities.
- E. Participant has received either medical clearance from his/her physician prior to participation in the Activities or has determined that such clearance is not necessary for his/her safe participation in the Activities.
