- A Security Deposit, payable to Northampton Township, is due at least 21 calendar days prior to use, in the amount of \$500 for all fields, tracks and
  trails, and \$100 for hockey rink and all courts. This amount does not include any staff costs or additional fees. Security Deposit will be returned upon
  satisfactory inspection of rented facility when no damages are found or reported.
- If both a Picnic Pavilion and a field/court are included on the same Facility Use Application, a single application fee of \$50 will apply.
- . Application fee for multiple uses of the same field or court during the same season, submitted on the same application, where allowed, will be \$100.

Fee schedules for Indoor Recreation Facilities, Pavilion & Amphitheater Use, and Seasonal, Camp, Tournament & Special Event use are included on separate sheets.
